A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, RESCINDING THE AUTHORIZATION OF THE PURCHASE OF FOUR REFUSE COMPACTION BODIES FROM PATTON EQUIPMENT COMPANY; FINDING THAT AN EMERGENCY EXISTS; AND AUTHORIZING THE PURCHASE OF FOUR REFUSE COMPACTION BODIES FROM J & R SUPPLY COMPANY.

WHEREAS, the City of Abilene duly advertised and gave such notice as required by law for bids for the purchase of Four Refuse Compaction Bodies for the use of the Refuse Disposal Department, City of Abilene, Texas; and,

WHEREAS, bids were received and opened on September 19, 1966, said net bids being as follows:

Patton Equipment Company	17,912.00
Davis Truck Parts	19,580.00
J & R Supply Company	19,498.00
Industrial Disposal Supply Company	22,512.60

WHEREAS, by Resolution dated October 6, 1966, the City Council authorized the purchase of such compaction bodies from Patton Equipment Company; and

WHEREAS, Patton Equipment Company has wholly failed to perform and has abandoned any contract which it may have had with the City of Abilene; and

WHEREAS, an emergency exists and, in order to preserve and protect the public health of the citizens of the City of Abilene, it is necessary to immediately purchase such Refuse Compaction Bodies without again advertising for bids thereon; and

WHEREAS, an acceptance of the second lowest responsible bid, made by J & R Supply Company, constitutes substantial compliance with the laws of this State requiring competitive bidding; and

WHEREAS, it is the opinion of the City Council that the bid of J & R Supply Company in the total net amount of \$19,498.00 should be accepted; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE,


TEXAS:

Section 1: That the bid of J & R Supply Company for the purchase of Four Refuse Compaction Bodies in the total amount of \$19,498.00 be, and the same is hereby, in all things approved and accepted.


Section 2: That the Purchasing Agent be, and he is hereby, authorized to purchase such equipment from such firm.
