

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF CERTAIN STREET DEPARTMENT EQUIPMENT, FOR USE BY THE CITY OF ABILENE.

WHEREAS, the City of Abilene duly advertised, and gave such notice, as required by law, for bids for the purchase of certain Street Department Equipment, meeting specifications, for use by the City of Abilene; and

WHEREAS, such bids, as set forth in detail on the attached Tabulations of Bids, were received and opened on the 10th day of June, 1969; and

WHEREAS, it is the opinion of the City Council that the bids hereinafter set forth are the lowest and best responsible bids, meeting specifications, and should be accepted; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE,

TEXAS:

PART 1: That the bid of International Harvester Company, for the purchase of one (1) Street Department truck, in the net amount of Three Thousand Six Hundred Ninety and 57/100ths Dollars (\$3,690.57), be, and the same is hereby, in all things, accepted.

PART 2: That the bid of Plains Machinery Company, for the purchase of one (1) used self propelled rock spreader, in the net amount of Thirteen Thousand Five Hundred and no/100ths Dollars (\$13,500.00), be, and the same is hereby, in all things, accepted.

PART 3: That the alternate bid of Eagle Equipment Company, for the purchase of one (1) used vibrating pull type rollers, in the net amount of Two Thousand Two Hundred Fifty and no/100ths Dollars (\$2,250.00), be, and the same is hereby, in all things, accepted.

PART 4: That the bid of Conley Lott Nichols, for the purchase of one (1) electric asphalt heater, in the net amount of Two Thousand Six Hundred Thirty-Six and no/100ths Dollars (\$2,636.00), be, and the same is hereby, in all things, accepted.

PART 5: That the bid of Godsey-Evans Inc., for the purchase of one (1) bituminous distributor, in the net amount of Eight Thousand One Hundred Sixty-Four and 50/100ths Dollars (\$8,164.50), be, and the same is hereby, in all things, accepted.

PART 6: That the bid of Plains Machinery Company, for the purchase of one (1) pulvimixer and one (1) spraybar, in the net amount of Sixteen Thousand Three Hundred Fifty and no/100ths Dollars (\$16,350.00), be, and the same is hereby, in all things, accepted.

PART 7: That the Purchasing Agent be, and the same is hereby, in all things, accepted.

PART 8: That this resolution shall take effect immediately from and after its passage.
