A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF PICKUPS, AUTOMOBILES AND TRUCKS, MEETING SPECIFICATIONS, FOR USE BY THE CITY OF ABILENE.

WHEREAS, the City of Abilene duly advertised, and gave such notice as required by law, for bids for the purchase of certain Pickups, Automobiles and Trucks, for use by the City of Abilene; and

WHEREAS, such bids, as set forth on the Tabulation of Bids, attached hereto, were received and opened on the 28th day of November, 1967; and
