A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF PARK EQUIPMENT, MEETING SPECIFICATIONS, AND APPROPRIATING FUNDS FOR THE PURCHASE THEREOF FROM PARK BOND FUNDS.

WHEREAS, the City of Abilene duly advertised, and gave such notice as required by law, for bids for the purchase of Park Equipment, for utilization by the Parks & Recreation Department of the City of Abilene, Texas; and

WHEREAS, such bids, as set forth on the Tabulation of Bids, attached hereto, were received and opened on the 28th day of November, 1967; and

WHEREAS, it is the opinion of the City Council that the bids of Paul E. Allen Company; Vaughn O. Euteneuer and Mexico Forge, Inc., for the items hereinafter enumerated, are the lowest, responsible bids, meeting specifications, and should be accepted; now, therefore,
