A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF LIGHT FIXTURES, MEETING SPECIFICATIONS, FOR USE BY THE PARKS & RECREATION DEPARTMENT OF THE CITY OF ABILENE.

WHEREAS, the City of Abilene duly advertised, and gave such notice, as required by law, for bids for the purchase of light fixtures, meeting specifications, for use by the Parks & Recreation Department of the City of Abilene; and

WHEREAS, the following bids were received and opened on the 4th day of April, 1968:

WHEREAS, it is the opinion of the City Council that the bid of Cummins Supply Company, in the amount of Three Thousand Six Hundred Twenty and 88/100 Dollars (\$3,620.88), less a two percent (2%) discount, for a net amount of Three Thousand Five Hundred Forty Eight and 46/100 Dollars (\$3,548.46), is the best responsible bid, meeting specifications, and should be accepted; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE,

TEXAS:

PART 1: That the bid of Cummins Supply Company, for the purchase of eighteen (18) light fixtures, in the amount of Three Thousand Six Hundred Twenty and 88/100 Dollars (\$3,620.88), less a two percent (2%) discount, for a net amount

of Three Thousand Five Hundred Forty Eight and 46/100 Dollars (\$3, 548. 46),
 be, and the same is hereby, in all things, accepted and approved.

PART 2: That the Purchasing Agent be, and he is hereby, authorized
 to purchase such fixtures from said firm.

PART 3: That this resolution shall take effect immediately from and
 after its passage.
