A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF ONE REFUSE COMPACTION BODY, FOR USE BY THE REFUSE DISPOSAL DEPARTMENT OF THE CITY OF ABILENE.

WHEREAS, the City of Abilene duly advertised, and gave such notice, as required by law, for bids for the purchase of one (1) refuse compaction body, meeting specifications, for use by the Refuse Disposal Department of the City of Abilene; and

WHEREAS, the following bids were received and opened on the 25th day of November, 1968:

WHEREAS, it is the opinion of the City Council that the bid of Pak-Mor Manufacturing Company, in the amount of Eight Thousand Eight Hundred Ninety and No/100 Dollars (\$8,890.00), is the lowest and best responsible bid, meeting specifications, and should be accepted; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE,

TEXAS:

PART 1: That the bid of Pak-Mor Manufacturing Company, for the purchase of one refuse compaction body, in the amount of Eight Thousand Eight Hundred Ninety and No/100 Dollars (\$8,890.00), be, and the same is hereby, in all things, approved.

PART 2: That the Purchasing Agent be, and he is hereby, authorized to purchase such compaction body from such firm.

PART 3: That the borrowing of the sum of Eight Thousand Eight Hundred One and 10/100 Dollars (\$8, 801. 10), (being the amount of such bid less a 1% discount), or any fraction thereof, is hereby authorized, and the Mayor is hereby authorized to execute a Promissory Note covering all, or any portion of, said sum, which said Promissory Note may also include additional sums authorized, by the City Council, to be borrowed by the City of Abilene.

PART 4: That this resolution shall take effect immediately from and after its passage.
