A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF POLICE CARS, STATION WAGONS, PASSENGER CARS AND A FIRE MARSHAL'S CAR.

WHEREAS, the City of Abilene duly advertised, and gave such notice, as required by law, for bids for the purchase of various police cars, station wagons, passenger cars and a Fire Marshal's car, for use by the City of Abilene; and

PART 7: That the bid of Hill & Hill Motor Company, for the purchase of one (1) Fire Marshall's car, in the net amount of Two Thousand Two Hundred Two and 71/100 Dollars (\$2,202.71), be, and the same is hereby, in all things, approved.

PART 8: That the bid of Hill & Hill Motor Company, for the purchase of one (1) Fire Department Passenger Car, in the net amount of Two Thousand One Hundred Eighty Six and 13/100 Dollars (\$2,186.13), be, and the same is hereby, in all things, approved.

PART 9: That the Purchasing Agent be, and he is hereby, authorized to purchase such vehicles from such firms.

PART 10: That this resolution shall take effect immediately from and after its passage.
