

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF TRUCKS AND TANDEM TRACTORS, FOR USE BY THE CITY OF ABILENE.

WHEREAS, the City of Abilene duly advertised, and gave such notice, as required by law, for bids for the purchase of various trucks and tandem tractors, meeting specifications, for use by the City of Abilene; and

WHEREAS, such bids, as set forth in detail on the attached Tabulation of Bids, were received and opened on the 25th day of November, 1968; and

WHEREAS, it is the opinion of the City Council that the bids hereinafter set forth are the lowest and best responsible bids, meeting specifications, and should be accepted; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the bid of M & G GMC Trucks, Inc., for the purchase of one (1) container truck, in the net amount of Ten Thousand Two Hundred Fifty Four and 57/100 Dollars (\$10,254.57), be, and the same is hereby, in all things, approved.

PART 2: That the bid of International Harvester Company, for the purchase of two (2) tandem tractors, in the net amount of Eleven Thousand Nine Hundred Nine and 74/100 Dollars (\$11,909.74) each, be, and the same is hereby, in all things, approved.

PART 3: That the bid of International Harvester Company, for the purchase of four (4) compaction body trucks, in the net amount of Seven Thousand Eight Hundred Fifteen and 73/100 Dollars (\$7,815.73) each, be, and the same is hereby, in all things, approved.

PART 4: That all bids, for the purchase of one (1) truck chassis, are hereby, in all things, rejected.

PART 5: That the bid of M & G GMC Trucks, Inc., for the purchase of one (1) flat bed truck, in the net amount of Two Thousand Eight Hundred Thirty Four and No/100 Dollars (\$2,834.00), be, and the same is hereby, in all things, approved.

PART 6: That the bid of M & G GMC Trucks, Inc., for the purchase of three (3) dump trucks, in the net amount of Thirteen Thousand Three Hundred Fifty Seven and 32/100 Dollars (\$13,357.32), for all of such dump trucks, be, and the same is hereby, in all things, approved.

PART 7: That the borrowing of the sum of Thirty Nine Thousand Three Hundred Eighty Seven and 57/100 Dollars (\$39,387.57), or any fraction thereof, is hereby authorized, and the Mayor is hereby authorized to execute a Promissory Note covering all, or any portion of, said sum, which said Promissory Note may include additional sums authorized, by the City Council, to be borrowed by the City of Abilene.

PART 8: That the Purchasing Agent be, and he is hereby, authorized to purchase such trucks and tractors from such firms.

PART 9: That this resolution shall take effect immediately from and after its passage.
