

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF TRUCKS AND PICKUPS, FOR USE BY THE CITY OF ABILENE.

WHEREAS, the City of Abilene duly advertised, and gave such notice, as required by law, for bids for the purchase of various trucks and pickups, meeting specifications, for use by the City of Abilene; and

WHEREAS, such bids, as set forth in detail on the attached Tabulation of Bids, were received and opened on the 25th day of November, 1968; and

WHEREAS, it is the opinion of the City Council that the bids hereinafter set forth are the lowest and best responsible bids, meeting specifications, and should be accepted; now, therefore,

PART 3: That the bid of International Harvester Co., for the purchase of three (3) - one-half (1/2) ton pickups, in the net amount of Two Thousand One Hundred Twenty Nine and 60/100 Dollars (\$2, 129.60) each, be, and the same is hereby, in all things, approved.
