A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF FOUR (4) REFUSE COMPACTION BODIES FOR USE BY THE REFUSE DISPOSAL DEPARTMENT OF THE CITY OF ABILENE.

WHEREAS, the City of Abilene duly advertised, and gave such notice, as required by law, for bids for the purchase of four (4) refuse compaction bodies, meeting specifications, for use by the Refuse Disposal Department of the City of Abilene; and

WHEREAS, the following bids were received and opened on the 25th day of November, 1968:

WHEREAS, it is the opinion of the City Council that the bid of Pak-Mor Manufacturing Company, in the amount of Seventeen Thousand Six Hundred Dollars (\$17, 600. 00), less a one percent (1%) discount, for a net amount of Seventeen Thousand Four Hundred and Twenty Four Dollars (\$17, 424. 00), is the lowest and best responsible bid, meeting specifications, and should be accepted; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE,

TEXAS:

PART 1: That the bid of Pak-Mor Manufacturing Company, for the purchase of four (4) refuse compaction bodies, in the net amount of Seventeen Thousand Four Hundred and Twenty Four Dollars (\$17, 424. 00), be, and the same is hereby, in all things, approved.

PART 2: That the borrowing of the sum of Nine Thousand Six Hundred Dollars (\$9,600.00), or any fraction thereof, is hereby authorized, and the Mayor is hereby authorized to execute a Promissory Note covering all, or any portion of, such amount.

PART 3: That the Purchasing Agent be, and he is hereby, authorized to purchase such compaction bodies from such firm.

PART 4: That this resolution shall take effect immediately from and after its passage.
