A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF CONTAINERS, MEETING SPECIFICATIONS, FOR USE BY THE REFUSE DISPOSAL DEPARTMENT OF THE CITY OF ABILENE.

WHEREAS, the City of Abilene duly advertised, and gave such notice, as required by law, for bids for the purchase of forty-eight (48) - three (3) cubic yard containers; sixty-four (64) - four (4) cubic yard containers, and twenty-eight (28) - eight (8) cubic yard containers, for use by the Refuse Disposal Department of the City of Abilene; and

WHEREAS, the following bids were received and opened on the 25th day of November, 1968:

Industrial Disposal Supply	\$ 27,916.00	1% - 15 Days

WHEREAS, it is the opinion of the City Council that the bid of Industrial Disposal Supply, in the total amount of Twenty Seven Thousand Nine Hundred Sixteen and No/100 Dollars (\$27,916.00), less a one percent (1%) discount, for a net amount of Twenty Seven Thousand Six Hundred Thirty Six and 84/100 Dollars (\$27,636.84), is the lowest and best responsible bid, meeting specifications, and should be accepted; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE,

TEXAS:

PART 1: That the bid of Industrial Disposal Supply, for the purchase of containers, as hereinabove described, in the net amount of Twenty Seven Thousand Six Hundred Thirty Six and 84/100 Dollars (\$27,636.84), be, and the same is hereby, in all things, approved.

PART 2: That the borrowing of the sum of Twenty Seven Thousand Six Hundred Thirty Six and 84/100 Dollars (\$27,636.84), or any fraction thereof, is hereby authorized, and the Mayor is hereby authorized to execute a Promissory Note covering all, or any portion of, said sum, which said Promissory Note may also include additional sums authorized, by the City Council, to be borrowed by the City of Abilene.

PART 3: That the Purchasing Agent be, and he is hereby, authorized to purchase such containers from such firm.

PART 4: That this resolution shall take effect immediately from and after its passage.
