A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, ORDERING AN ADVISORY VOTE TO BE HELD ON APRIL 3, 1973, ALONG WITH THE CITY ELECTION FOR COUNCILMEN TO BE HELD AT THAT TIME, ON WHETHER OR NOT THE CITY OF ABILENE SHOULD OR SHOULD NOT ALLOW AN EXEMPTION OF \$3,000.00 OF THE ASSESSED VALUE OF RESIDENT HOMESTEADS OF PERSONS 65 YEARS OF AGE OR OLDER, PROVIDING THAT ALL DULY QUALIFIED RESIDENT ELECTORS SHALL BE QUALIFIED TO VOTE; PRESCRIBING FORM OF BALLOT TO BE USED.

WHEREAS, the City Council of the City of Abilene desires that an advisory vote be held in the City of Abilene on whether or not the City Council should or should not allow an exemption of \$3,000.00 of the assessed value of resident homesteads of all persons 65 years of age or older; and,

WHEREAS, the City Council of the City of Abilene desires that the advisory vote be taken at the same time and place that the city election for City Councilmen is to be held on April 3, 1973; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the advisory vote is to be held in and throughout the City of Abilene, Texas, on the 3rd day of April, 1973, at which time there shall be submitted to the resident qualified voters of the City of Abilene, the following vote:

FOR the City of Abilene allowing an exemption of \$3,000.00 ~~as~~<sup>f</sup> the assessed value of resident homesteads of all persons 65 years of age or older

AGAINST the City of Abilene allowing an exemption of \$3,000.00 ~~as~~<sup>t</sup> the assessed value of resident homesteads of all persons 65 years of age or older

PART 2: That said advisory vote shall be held in each of the election precincts within the City of Abilene for the election of City Councilmen for the City of Abilene, and the polling places and presiding officers for each of said precincts shall be those that are appointed to carry out their functions and duties in the city election.

PART 3: That absentee voting for the advisory vote shall be conducted at the office of the City Secretary in the City Hall, Abilene, Texas, until 5:00 p.m., Friday, March 30, 1973.

PART 4: That all electors that are qualified to vote in the city election for City Councilmen are qualified to vote on the advisory vote ballot.
