A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS,
AUTHORIZING THE PURCHASE OF MOWERS AND TRACTORS, MEETING
SPECIFICATIONS, FOR USE BY THE CITY OF ABILENE.

WHEREAS, the City of Abilene duly advertised and gave notice, as required by law, for bids for the purchase of mowers and tractors, meeting specifications, for use by the City of Abilene; and,

WHEREAS, bids were received on April 1, 1975, as shown on the attached Exhibit "A"; and,

WHEREAS, it is the opinion of the City Council that the low bid of Godsey-Evans, less trade-ins, for Item 1, for the amount shown, is the lowest and best responsible bid, meeting specifications, and should be accepted; and,

WHEREAS, it is the opinion of the City Council that the low bid of Shaddix Implement Company, less trade-in, for Item 2, for the amount shown, is the lowest and best responsible bid, meeting specifications, and should be accepted; and,

WHEREAS, it is the opinion of the City Council that the low bid of Case Tractors, Inc. less trade-in, for Item 3, for the amount shown, is the lowest and best responsible bid, meeting specifications, and should be accepted; and,

WHEREAS, it is the opinion of the City Council that the low bid of Godsey-Evans, for Item 4, for the amount shown, is the lowest and best responsible bid, meeting specifications, and should be accepted; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the low bid of Godsey-Evans, for the purchase of 7 -7' Nail mowers, Item 1, in the amount of Seven Thousand Eight Hundred Fifty-One and 90/100ths (\$7,851.90) Dollars, is the lowest and best responsible bid, meeting specifications, and the same is hereby, in all things, approved and accepted.

PART 2: That the low bid of Shaddix Implement Company, for the purchase of 1 - 6' rotary mower, Item 2, in the amount of Seven Hundred Ninety-Three and 00/100ths (\$793.00) Dollars, is the lowest and best responsible bid, meeting specifications, and the same is hereby, in all things, approved and accepted.

PART 3: That the low bid of Case Tractors, Inc., for the purchase of 2 - tractor type lawn mowers, Item 3, in the amount of Two Thousand Three Hundred Eighty-Six and 00/100ths (\$2,386.00) Dollars, is the lowest and best responsible bid, meeting specifications, and the same is hereby, in all things, approved and accepted.

PART 4: That the low bid of Godsey-Evans, for the purchase of 1 - 15' flail mower, Item 4, in the amount of Three Thousand Six Hundred Seventy-Two and 00/100ths (\$3,672.00) Dollars, is the lowest and best responsible bid, meeting specifications, and the same is hereby, in all things, approved and accepted.

PART 5: That the Purchasing Agent be, and he is hereby authorized to make such purchases from said companies.

PART 6: That this resolution shall take effect immediately from and after its passage.
