A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF ROOFING, MEETING SPECIFICATIONS, FOR USE BY THE CITY OF ABILENE.

WHEREAS, the City of Abilene duly advertised and gave such notice, as required by law, for bids for the purchase of roofing for repair on parks buildings, meeting specifications, for use by the City of Abilene; and,

WHEREAS, the following bids were received and opened on the 19th day of August, A.D. 1975:



