A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AMENDING THE POLICY FOR PAVING ASSESSMENT RATES AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Abilene has enacted certain policies relating to street paving assessment procedures and costs; and,

WHEREAS, the City Council is of the opinion that the written policies for the paving of streets should be changed, as below set out; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That, from and after April 8, 1976, the following policies relating to street paving assessment procedures in the City of Abilene, Texas, shall be in full force and effect.

I. The following assessment rates shall apply in Community Development Program Target Areas:

- Paving Standards: Standard Concrete Curb and Gutter
6" Lime Stabilized Subgrade
6" Crushed Limestone Base
2 Course Asphalt Penetration Paving

Residential Paving Rates:

Table with 2 columns: Paving on Front Lot (Curb & Gutter Paving, Total) and Rate by Street Width (Face to Face of Curb) (30', 36', 40').

Paving on Side or Rear Lot

Table with 2 columns: Curb & Gutter Paving, Total and Rate by Street Width (Face to Face of Curb) (30', 36', 40').

Commercial Paving Rates:

Table with 3 columns: Curb & Gutter Paving, Total and Rate by Street Width (Face to Face of Curb) (30', 36', 40', 44', 48', 52', 56', 60', 64').

(Platted Prior To 1975):

The following streets shall be treated as being in Newly Developing Areas platted subsequent to January 1, 1975, for assessment paving purposes: E.N. 10th, Griffith Road, Lowden St. (from I.H.20 East), Eastview Drive, Hillside Drive, Jolly Roger Road, County Roads north of Henson St., Shirley Road, Hayter Road, Marigold St., No. 10th St. west of Wall, No. Main St., Vapor Trail, Chapel Hill Road, Corsicana Ave., Andy St., Texas Ave., Bishop Road, Jennings Drive, Curry Lane, Rebecca Lane, McGee Drive, East Industrial Blvd., Berry Lane and any street deferred from paving prior to passage of this resolution due to special problems or at the request of the developer or landowners affected.

Notwithstanding the foregoing, any street in an Existing Developed Area platted prior to January 1, 1975, that is dedicated to the public use after passage of this resolution, shall be assessed on the basis of rates for Newly Developing Areas for assessment paving purposes.


PART 2: That all other provisions of the street paving assessment procedures adopted the 24th day of February 1966, shall remain in full force and effect.

PART 3: That this resolution shall take effect immediately from and after its passage.
