A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS,
AUTHORIZING THE PURCHASE OF CARS AND TRUCKS, MEETING SPECIFICATIONS,
FOR USE BY THE CITY OF ABILENE; REJECTING BID ON FIRE DEPT. VAN AND
AUTHORIZING THE PURCHASING AGENT TO READVERTISE SAME.

WHEREAS, the City of Abilene duly advertised and gave such notice, as
required by law, for bids for the purchase of cars and trucks, meeting specifications,
for use by the City of Abilene; and,

PART 3: That the bid received for one (1) Fire Department van be, and the same is hereby, in all things rejected, and that the Purchasing Agent be, and is hereby authorized to readvertise same.


PART 4: That this resolution shall take effect immediately from and after its passage.
