A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF CENTURY CORDED FLOOR COVERING, MEETING SPECIFICATIONS, FOR USE BY THE CITY OF ABILENE.
