A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS,
AUTHORIZING THE PURCHASE OF FLOOR TILE AND ACOUSTICAL CEILING TILE,
MEETING SPECIFICATIONS, FOR USE BY THE CITY OF ABILENE.
