A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE SANDBLASTING OF TENNIS COURTS AT ROSE PARK TENNIS CENTER.

WHEREAS, the City of Abilene duly advertised and gave notice, as required by law, that bids were to be received for sandblasting of tennis courts at Rose Park Tennis Center; and,

WHEREAS, bids were received on August 30, 1977, as shown on the attached Exhibit "A"; and,

WHEREAS, it is the opinion of the City Council that the bid of American Sandblasting, in the amount of Four Thousand Five Hundred Dollars (\$4,500.00), should be accepted; now, therefore,



