A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE CITY ENGINEERING DEPARTMENT TO PREPARE PLANS AND SPECIFICATIONS FOR THE IMPROVEMENT OF PORTIONS OF THE HEREAFTER NAMED STREETS.

WHEREAS, the City Council is of the opinion that certain portions of the hereinafter named streets should be improved; and,

WHEREAS, the City Council is of the opinion that the City Engineering Department should be authorized to prepare plans and specifications for such hereinafter named streets; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the Engineering Department of the City of Abilene be, and is hereby authorized to prepare plans and specifications for the improvement of the designated portions of the following streets:

UNIT I - 30' WIDE STREETS F/C to F/C

1. Walnut St. from Ambler Ave. to Sandefer St.
2. Palm St. from So. 34th St. to So. 32nd St.
3. Beech St. from No. 20th St. to No. 21st St.
4. No. 20th St. from Grape St. to Simmons St.
5. So. 17th St. from Oak St. to 413' East
6. Orange St. from Lowden St. to Anson Ave.
7. Longbotham St. from Berry Lane to 506' North
8. Oscar St. from Longbotham St. to Lakeside Dr.
- * 9. Fulton St. from Sewell St. to Marshall St.
- *10. So. 23rd St. from East of Jeanette St. to Poplar St.
- *11. Amarillo St. from So. 17th St. to So. 19th St.
- *12. So. 8th St. from Sunset Dr. to Sammons St.
- *13. Parramore St. from Kirkwood St. to Park
- *14. No. 14th St. from Lillius St. to Victoria St.
- *15. No. 16th St. from alley East of Lillius St. to Victoria St.
- *16. Hardy St. from No. 19th St. to Ambler St.

UNIT II - 36' WIDE STREETS F/C to F/C

1. Catalaw Dr. from Rebeca La. to 1345' South
2. Lowden St. from Grape St. to Simmons St.
3. Melrose St. from Ross Ave. to Grand Ave.
4. Pecan St. from Westway Dr. to So. 14th St.

UNIT III - 40' WIDE STREET F/C to F/C

1. So. 15th St. from Al. E. of Treadaway Blvd. to Maple St.
