A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING THE PURCHASE OF SPRINKLER HEADS, MEETING SPECIFICATIONS, FOR USE BY THE CITY OF ABILENE.

WHEREAS, the City of Abilene duly advertised and gave notice, as required by law, for bids for the purchase of sprinkler heads, meeting specifications, for use by the City of Abilene; and,

WHEREAS, bids were received on May 2, 1978, as shown on the attached Exhibit "A"; and,

WHEREAS, it is the opinion of the City Council that the bid of Goldthwaite's

for the amount shown, is the lowest and best responsible bid, meeting specifications, and should be accepted; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the bid of Goldthwaite's for the purchase of sprinkler heads, in the amount of Five Thousand Eight Hundred Thirty and 50/100ths (\$5,830.50) Dollars, is the lowest and best responsible bid, meeting specifications, and the same is hereby, in all things, approved and accepted.

PART 2: That the Purchasing Agent be, and he is hereby authorized to make such purchase from said company.

PART 3: That this resolution shall take effect immediately from and after its passage.



