

RESOLUTION NO. 11-1984

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AMENDING THE EXHIBIT "A" ATTACHED TO RESOLUTION NO. 2-1984 ADOPTED BY THE CITY COUNCIL ON JANUARY 26, 1984 RELATIVE TO AUTHORIZATION FOR RIGHT OF WAY ACQUISITION FOR THE FEDERALLY FUNDED F.M. 3438 PROJECT.

WHEREAS, on January 26, 1984 the City Council of the City of Abilene officially determined that there is a public necessity for, and the public welfare and convenience will be served by, the acquisition of the property described in an Exhibit "A" attached and thereto made a part of Resolution No. 2-1984 for all purposes as a part of the F.M. 3438 Project in Abilene for the purposes of improving and extending F.M. 3438 from Spur 312 to approximately 500 feet south of the centerline of Jennings Drive which is also the approximate City Limit; and,

WHEREAS, it has since been necessary for the Texas State Department of Highways and Transportation to make some minor adjustments to the property descriptions as presented January 26, 1984; and,

WHEREAS, these changes have been incorporated into the attached Exhibit "A" and made a part of this resolution to amend the descriptions previously presented to the Council on January 26, 1984; and,

WHEREAS, this resolution changes only the property descriptions as needed and does not alter the remaining portions of Resolution 2-1984 approved on January 26, 1984 authorizing the acquisition process for the property necessary to complete the federally funded F.M. 3438 Project; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE:


PART 1: That the Exhibit "A" attached hereto and made a part of this resolution is hereby approved.
