

RESOLUTION NO. 46-1984

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, APPROVING THE FILING OF AN APPLICATION FOR A COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM.

WHEREAS, notice was given on September 17, 1974, at 39 Federal Register 33482, that the Department of Housing and Urban Development was proposing to amend Title 24 of the Code of Federal Regulations by adding a new part 570 to Chapter V; and,

WHEREAS, such proposed amendment was subsequently made and published in the federal register on November 13, 1974; and,

WHEREAS, the purpose of Part 570 is to set forth regulations governing the use of funds under Title I of the Housing and Community Development Act of 1974, Public Law 93-383, as amended, which provides for a new program of Community Development Block Grants to begin on October 1, 1984; and,

WHEREAS, it is desirable and in the public interest that the City of Abilene request funds under the Community Development Block Grant Program for the City of Abilene situated in the County of Taylor and the State of Texas; and,

WHEREAS, a public hearing has been held as required by said Act, at which public hearing interested members of the public were invited to offer comments regarding the various programs to be undertaken under the Act; and, WHEREAS, the primary objective of the Community Development Program is to develop a viable urban community including decent housing and suitable living environment and expanding economic opportunities principally for persons of low and moderate income. Consistent with this primary objective, the Federal assistance provided in the Community Development Program is for the support of Community Development activities which are outlined and enumerated in Section 570.2 of said Chapter V; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART I: That the filing of the Application by the City of Abilene for a Community Development Block Grant under Chapter V of Title 24 of the Code of Federal Regulations in the amount of One Million Two Hundred Sixty-One Thousand and 00/000ths (\$1,261,000.00) Dollars, to assist in carrying out Community Development activities for the locality, is hereby authorized and approved. The Mayor of the City of Abilene is hereby authorized to sign said

application and any and all appurtenant documents on behalf of the City.

PART 2: That the financial assistance authorized by the Community Development Block Grant Program referred to above is required to enable the City of Abilene to carry on appropriate Community Development activities aimed toward meeting the objectives stated above.

PART 3: That this resolution shall take effect immediately from and after its passage.
