RESOLUTION NO. 31-1986

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AMENDING RESOLUTION 109-1985 ADOPTED THURSDAY, NOVEMBER 7, 1985, AND RESOLUTION 1-1986 ADOPTED THURSDAY, JANUARY 9, 1986, AND RESOLUTION NO. 15-1986 ADOPTED THURSDAY, MAY 8, 1986, AUTHORIZING THE ACQUISITION OF LAND AND APPROPRIATION OF FUNDS FOR THE CEDAR CREEK (1-20 TO BUCK CREEK) WIDENING PROJECT.

WHEREAS, on Thursday, November 7, 1985, the City Council of the City of Abilene determined the necessity of establishing procedures for the establishment and approval of just compensation for the fee simple title to each of the parcels to be acquired for such project; and,

WHEREAS, the City Council authorized the staff to proceed with the necessary procedures to acquire said parcels; and,

WHEREAS, there is a need to correct a Volume/Page reference in order to assure the land acquisition records are accurate during this process; and

WHEREAS, said changes have been made and are attached as Exhibit "A" and made a part of the resolution adopted on November 7, 1985; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That all the provisions of the resolution approved on November 7, 1985 shall remain in full force and effect and all steps taken pursuant to the November 7, 1985 resolution were ratified and approved on May 8, 1986.

PART 2: That City Council approve and make a part of this Resolution the attached Exhibit "A" which changes only the Volume/Page reference in the Morgan Tract.

PART 3: That the City Council of the City of Abilene hereby authorizes the Mayor to execute this resolution.

PART 4: That this resolution shall take effect immediately from and after its passage.

TRACT I

OWNER: WEST TEXAS UTILITIES

THENCE S 39° 09' 42" W, at 383.7 feet cross the South boundary line of said Section 83, T&P Railroad Land, Block 14, and the North boundary line of said Section 84, T & P Railroad Land, Block 14, which is also known as M. Martin Survey #84, a total distance of 1099.4 feet to an iron stake located in the Northerly right-of-way line of Interstate Highway #20;

THENCE S 50° 54' E, 300 feet along said Northerly right-of-way line of Interstate Highway #20 to an iron stake;

THENCE N 39° 09' 42" E, at 946.7 feet cross the said North line of said Section 84, T & P Railroad Land, Block 14, which is also known as M. Martin Survey #84 and the South line of said Section 83, T&P Railroad Land, Block 14, a total distance of 1099.1 feet to an iron stake located on a curve to the left;
