

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, APPOINTING VARIOUS ELECTION OFFICIALS AND FIXING THEIR RATE OF COMPENSATION.

WHEREAS, the City Council has previously ordered a Runoff Election for May 5, 1987; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: The individuals listed on the attached Exhibit "A" are designated as Presiding Judges and Alternate Presiding Judges for their respective Polling Places.

The maximum number of clerks for each voting precinct shall be four (4), and each judge shall attempt to appoint one (1) clerk fluent both in English and Spanish.


The rate of compensation shall be Five and 00/100ths (\$5.00) Dollars, per hour; provided, however, that each presiding judge delivering returns of the election shall be paid an additional Twenty-Five and 00/100ths (\$25.00) Dollars, for that service.

The City Council further finds that absentee ballots shall be counted by the Special Canvassing Board, as provided for by law.

PART 2: That this resolution shall take effect immediately from and after its passage, as indicated below.


