RESOLUTION NO. 41-1987

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AMENDING RESOLUTION NO. 26-1987, DECLARING A PUBLIC NECESSITY FOR THE ACQUISITION OF RIGHT-OF-WAY AND GIVING NOTICE OF AN OFFICIAL DETERMINATION TO ACQUIRE SAID RIGHT-OF-WAY FOR THE CEDAR CREEK (AMBLER AVENUE NORTH TO I-20) WIDENING PROJECT; ESTABLISHING PROCEDURES FOR THE ACQUISITION; AND APPROPRIATING FUNDS.

WHEREAS, on Thursday, May 5, 1987, the City Council of the City of Abilene set out limits and acquisition authorization for this section of the Cedar Creek project; and said resolution now needs to be amended to include an additional parcel and authorization to acquire Parcel No. 1 in either fee simple title or by easement; and,

WHEREAS, it is necessary to establish procedures for determining the establishment and approval of just compensation for the fee simple title for Parcels No. 2 through 8, and fee simple title or easement for Parcel No. 1, said parcels to be acquired for such project; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That this Resolution and its Exhibit "A" supercede Resolution No. 26-1987 and its Exhibit "A".

PART 2: That the City Council of the City of Abilene hereby officially determines that there is a public necessity for, and the public welfare and convenience will be served by, the acquisition of right-of-way property described in the attached Exhibit "A", said right-of-way giving the City of Abilene (1) the right to install or allow others to install any utilities within the boundaries of said right-of-way which the City may deem advisable, (2) the right to

straighten, improve, and widen Cedar Creek within the boundaries of the right-of-way, and (3) the right to destroy, damage, or remove from within the boundaries of said right-of-way without the payment of any compensation whatsoever any and all trees, brush, undergrowth, trash, dirt, debris, and any other obstruction, natural or man-made, including any building, structure, or fixture, on or over said right-of-way which in the City Engineer's sole determination may injure, obstruct, or interfere with the unrestricted flow of water across the property within the boundaries of the right-of-way or may injure, obstruct, or interfere with the installation of any utilities within the boundaries of the right-of-way. It is the City of Abilene's intention to acquire fee simple title to Parcels No. 2 through 8 and fee simple title or easement to Parcel No. 1 of the real property as set out and described in Exhibit "A", attached hereto and made a part of this resolution for all purposes, as part of the Cedar Creek Widening Project in Abilene for the purposes of flood control by improving, straightening, and widening of Cedar Creek from Ambler Avenue North to Interstate Highway 20.

PART 3: That the City Manager is hereby authorized to contract, on behalf of the City of Abilene, with professional appraisers for appraisal services and with attorneys for preparation of title policies needed by the City from time to time in connection with the acquisition of the above-described channel right-of-way for the Cedar Creek Widening Project.

PART 4: That the City Land Manager, or other staff

appraiser, is hereby authorized and directed to examine the independent appraisal reports as they are submitted to said City to determine whether said appraisal reports are supported by sufficient data. Based upon such examination of said appraisal reports, the Land Manager, or other staff appraiser, shall make a recommendation to the City Manager as to establishment and approval of the amount of the just compensation for said fee simple title to Parcels No. 2 through 8 and fee simple title or easement to Parcel No. 1.

PART 5: After consideration of said recommendation, the City Manager shall establish and approve the amount determined to be just compensation for acquisition of the above described fee simple title to Parcels No. 2 through 8 and fee simple title or easement to Parcel No. 1.

PART 6: Upon establishment and approval by the City Manager of the amount of just compensation for the acquisition, the Land Manager is authorized to communicate a written offer to the owner of said parcel for acquisition of said fee simple title to Parcels No. 2 through 8 and fee simple title or easement for Parcel No. 1 at the full amount determined and established to be just compensation therefor, and to negotiate with said owner on behalf of the City of Abilene.

PART 7: That the City Manager be and is hereby authorized to execute all documents necessary to acquire each of the said fee simple titles to Parcels No. 2 through 8 and fee simple title or easement for Parcel No. 1 of land needed for said project, on behalf

of the City of Abilene.

PART 8: That the amount of Eighty Thousand and no/100 (\$80,000.00) Dollars, be appropriated from the 1984 and 1986 Community Development Funds allocated for Cedar Creek Improvements for the acquisition of the channel right-of-way.

PART 9: That this resolution shall take effect immediately from and after its passage.
