

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, ACCEPTING THE PROVISIONS OF STATE HIGHWAY COMMISSION MINUTE ORDER

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

Part 1: That the City of Abilene accept the provisions contained in Minute Order Number 86779 passed by the State Highway and Public Transportation Commission on January 27, 1988, for the improvement by the State Department of Highways and Public Transportation of the city street described below:

WHEREAS, in TAYLOR COUNTY in the City of Abilene on REBECCA LANE, west from Catclaw Creek to U.S. Highway 277, a distance of approximately 2.0 miles, a reconstruction project is required; and

WHEREAS, this project qualifies for the 1988-92 Urban System Program (Non-Major Urbanized Areas) approved this date by State Highway and Public Transportation Commission action;

NOW, THEREFORE, IT IS ORDERED that the Engineer-Director is directed to tender the following proposal to the City of Abilene:

Provided the City of Abilene will:

1. Provide one hundred percent of the cost of right of way clear of obstructions and free of cost to the State with acquisition procedures to be in accordance with policies of the State Department of Highways and Public Transportation and with applicable Federal and State laws governing the acquisition policies for acquiring real property.
2. Provide one hundred percent of the cost of utility adjustments as may be required in accordance with policies of the State Department of Highways and Public Transportation.
3. Provide for the cost of construction of continuous curb and gutter, storm sewers, driveways and sidewalks, etc., in accordance with applicable governing policies and regulations of the State Department of Highways and Public Transportation.
4. Upon completion of the construction of this project, maintain that portion of the work which is its responsibility in accordance with federal and state requirements, and agree to regulate traffic and prevent encroachment on the right of way, all in accordance with governing policies and regulations of the State Department of Highways and Public Transportation.

The State Department of Highways and Public Transportation will:


1. Provide relocation assistance as may be determined to be eligible under the Relocation Assistance Program.
2. Provide for reconstruction.

Upon acceptance of the provisions of this Minute Order by the City of Abilene, IT IS ORDERED that the Engineer-Director is authorized to proceed in the most feasible and economical manner with project development to include any necessary agreements, right of way acquisition, utility adjustments, relocation assistance and reconstruction at an estimated cost to the Department of \$1,200,000 to be funded from the 1988-92 Urban System Program (Non-Major Urbanized Areas).

This order shall become operative upon acceptance by the City of Abilene; and if not accepted within 120 days of the date hereof, the action herein contained shall be automatically cancelled.

Part 2: That this resolution shall take effect immediately from and after its passage.
