A JOINT RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AND THE BOARD OF TRUSTEES, ABILENE INDEPENDENT SCHOOL DISTRICT; APPOINTING VARIOUS ELECTION OFFICIALS FOR THE JOINT CITY/SCHOOL ELECTION FOR THE MAY 7 AND MAY 21, 1988 ELECTIONS.

PART 3: The rate of compensation shall be Five and 00/100ths (\$5.00) Dollars per hour; provided, however, that each presiding judge delivering returns of the election shall be paid an additional Twenty-Five and 00/100ths (\$25.00) Dollars, for that service.

PART 4: Absentee ballots shall be counted by the Absentee Ballot Board, as provided for by law.

PART 5: That this resolution shall take effect immediately from and after its passage, as indicated below.

PART 6: That the Term of this appointment shall be for the May 7 election and the May 21 runoff election, if necessary.
