## RESOLUTION NO. 18-1988

- PART 2: It appearing that Gary D. McCaleb received the majority of votes cast in said election for the office of Council Place 1 and Betty Ray for the office of Council Place 2.
- PART 3: It appearing that the issue of Collective Bargaining has failed since it did not receive a majority of the votes cast in said election.
- PART 4: That this resolution shall take effect immediately from and after its passage.
