

RESOLUTION NO. 35-1988

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, APPROVING A FEE SCHEDULE FOR MAXWELL MUNICIPAL GOLF COURSE, AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City Council, in August, 1986, directed the City Manager and the staff to conduct cost studies from time-to-time of the various fees and charges of the City of Abilene, Texas, and submit recommendations to the City Council for their review of adjustment to and creation of said fees and charges as needed.

WHEREAS, American Golf Corporation has submitted a request to the City Manager to adjust the fee schedule at Maxwell Municipal Golf Course.

WHEREAS, the City of Abilene's Parks Board unanimously approved on June 7, 1988 a change in the golf course fees; now, therefore,


BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

Part 1: That the fee schedule herein called Exhibit 1 and attached hereto, be in all things, approved.


Part 2: That this resolution shall take effect October 1, 1988 after its passage and shall supersede golf course fee schedule in Resolution #9-1987.


