## RESOLUTION NO. 37-1988

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, ADOPTING THE CITY OF ABILENE EXTERRITORIAL JURISDICTION BOUNDARY MAP.

WHEREAS, the Planning and Zoning Commission of the City of Abilene, after careful study and after a public hearing, has recommended to this Council the City of Abilene Exterritorial Jurisdiction Boundary Map; and

WHEREAS, The Council has carefully considered the City of Abilene Exterritorial Jurisdiction Boundary Map and has held a public hearing thereon and finds that said map constitutes a suitable, logical and timely plan for present and future development of an exterritorial jurisdiction boundary; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the document consisting of metes and bounds description and map entitled "City of Abilene Exterritorial Jurisdiction Boundary Map" is hereby adopted.

PART 2: That in order that said plan shall at all times be current with the needs of the City of Abilene, and shall represent the concern of the Council, Planning and Zoning Commission and departments of the City that the plan be consistent with changing conditions, the Planning and Zoning Commission shall periodically review said document and recommend to the Council extensions, changes or additions which the Commission considers necessary.

PART 3: That this resolution shall take effect immediately from and after its passage.

## One Mile Extra Territorial Jurisdiction Boundary

Beginning at a point on Taylor County Rd. (TCR) #309 which is the southwest corner of the ETJ of the City of Tye. Said point being approximately 3300 ft. north, of TCR #310, on TCR #309.

- 1. From said point the line parallels TCR #310 in a general west southwest direction some 2000 ft. Then turning in a general southerly direction the line proceeds to a point on TCR #310 some 2000 ft. west, along the roadway, of TCR #309. This also being on the north boundary line of William B. Hardin Survey.
- 2. Thence the line proceeds south until intersecting TCR #311 at a point where said road makes a right angle turn from north/south to east/west and being some 6800 ft. west of FM 707. Following the north/south r.o.w. of said county road and projecting it further south, the line proceeds some 4600 ft. south to a point in William B. Hardin Survey where a projection of east/west TCR #312 intersects the line.
- 3. Thence the line proceeds east northeast along this projection to the east/west r.o.w. of TCR #312 and follows the roadway to FM 707. This point being some 4300 ft. north along FM 707 from U.S. Hwy. 277 and is also located on the west boundary of Edward Dickenson Survey some 2300 ft. away from the southwest corner of said survey.
- 4. Thence the line proceeds south southeast along the r.o.w. of FM 707 to the point of intersection with the r.o.w. of TCR #256. Said point being the southwest corner of John L. Smith Survey #53.
- 5. Thence the line proceeds south along the r.o.w. of TCR #256 to a point on the south boundary of James Vaughn Survey some 6400 ft. east of the southwest corner of said survey.
- Thence east along the south boundary of said survey to the northwest corner of D.L. Wilman Survey.
- 7. Thence the line proceeds south following the west boundary of said survey to the southwest corner.
- 8. Thence the line proceeds east along TCR #339 and #338 some 18,700 ft., generally being the south boundaries of D.L. Wilman and James M. Jett Surveys. Continuing east along a projection of said roadway the line intersects the west boundary of Survey 24 Lunatic Asylum Lands at the midpoint. Continuing along the same projection the line crosses said survey to a point on the east boundary of Survey 25. Said point being the southeast corner of the northeast quarter section of said survey.

9. Thence the line proceeds north to the northeast corner of Survey 25 Lunatic Asylum Lands. Turning to the east the line goes across the north boundary of Surveys 26 and 27 Lunatic Asylum Lands to the northeast corner of Survey 27.

- 10. Thence the line proceeds north along the east boundary of Survey 20 to the northeast corner of said survey.
- 11. Thence the line proceeds east following the north boundaries of Surveys 19 and 18 Lunatic Asylum Lands and Survey 25 Blk. 8 SP RR Co. Lands to the southeast corner of Survey 24 Blk. 8 SP RR Co. Lands.
- 12. Thence the line proceeds north following the east boundary of Surveys 24 and 21 Blk. 8 SP RR Co., and Surveys 3 Lunatic Asylum Lands and 58 Blind Asylum Lands, said line being the projection of Elmdale Road and Elmdale Road, to a point on the east boundary of Survey 58 Blind Asylum Lands. Said point being the northwest corner of the southwest quarter section of Survey 57.
- 13. Thence the line proceeds east to a point in the eastern boundary of said survey. Said point being the northeast corner of the southeast quarter section of said survey.
- 14. Thence north to the northeast corner of Survey 57 Blind Asylum Lands.
- 15. Thence east to the midpoint of the south boundary of Survey 7 Blk. 8 SP RR Co. Lands. Said point being the southeast corner of the southwest quarter section of said survey.
- 16. Thence north bisecting Surveys 7, 4, 3 and 1 Blk. 8 SP RR Co, through Anthony Bates Survey and Survey 65 Blk. 13 T&P Lands to a point on the north boundary of Survey 65 some 1300 ft. west of the northeast corner. Said point also being on Callahan County Rd. #112 at the Deadman Creek crossing.
- 17. Thence west to the midpoint of the south boundary of Survey 14 Blind Asylum Lands. This line also corresponding to the r.o.w. TCR #521. Said point being the southwest corner of the southeast quarter section of said survey.
- 18. Thence north bisecting Surveys 14, 13 and 6 Blind Asylum Lands to the midpoint of north boundary of Survey 6 Blind Asylum Lands. Said point being the northwest corner of the northeast quarter section of said survey.
- 19. Thence east along the north boundary of said survey the northeast corner.
- 20. Thence north following the r.o.w. of FM 1082, to the northwest corner of Survey 1, Blind Asylum Lands.

21. Thence east along the north boundary of Surveys 1 and 2 Blind Asylum Lands to the northeast corner of Survey 2 Blk. 14 T&P Lands.

- 22. Thence north along a projection of the east boundary of Survey 2 Blind Asylum Lands bisecting Survey 44 Blk. 14 T&P Lands to the northeast corner of said survey.
- 23. Thence the line proceeds in a north northwest direction along the east boundary of Survey 43, Blk. 14 T&P Lands to the northeast corner of said survey.
- 24. Thence east along the south boundary of Survey 35 Blk. 14 T&P Lands to Deadman Creek.
- 25. Thence the line proceeds in a north northwest direction some 2600 ft. parallel to the east boundary of Survey 35, bisecting Surveys 35 and 30 Blk. 14 T&P Lands, to a point on the northern boundary of Survey 30. Said point being the northeast corner of the northwest quarter section of Survey 30.
- 26. Thence the line proceeds west westsouth along the north boundary line of Survey 30 Blk. 14 T&P Lands to the northwest corner of said survey.
- 27. Thence the line proceeds north northwest along the west boundary of Survey 23 Blk. 14 T&P Lands to the northwest corner of said survey.
- 28. Thence the line proceeds west westsouth following a projection of the north boundary of Survey 23 Blk. 14 T&P Lands, across Surveys 21 & 22, following the north boundary of Survey 33 Blk. 14 T&P Lands to the northwest corner of said survey.
- 29. Thence south along the east boundary of Wm. T. Evans Survey to the Southeast corner of said survey.
- 30. Thence the line proceeds west along the south boundary of said survey to the Clear Fork of the Brazos River.
- 31. Thence the line proceeds south along the river to the northeast corner of John Smith Survey.
- 32. Thence west along the north boundary then south along the west boundary of John Smith Survey to the southwest corner of said survey.
- 33. Thence the line proceeds west along the north boundary of James Bennett Survey and a projection of said boundary across the James Halfpenny and Domingo Bustillos Survey to a point. Said point being on the west boundary of Domingo Bustillos Survey some 3200 ft. south along the boundary from the northwest corner.

34. Thence the line proceeds south southeast along the west boundary of said survey to FM 1082.

- 35. Thence The line proceeds along FM 1082 west southwest across Bragida Travenio Survey to a point of intersection with the west boundary of said survey.
- 36. Thence the line proceeds south southeast following the west boundary of Bragida Travenio Survey to the northeast corner of Survey 43, Blk. 16, T&P Lands.
- 37. Thence the line proceeds west westsouth along the north boundary of said survey to the northwest corner of said survey.
- 38. Thence the line proceeds along the west boundary of said survey south southeast along the west boundaries of Surveys 43, 44, 45, and 47 Blk. 16 T&P Lands to the northeast corner of Survey 48.
- 39. Thence the line proceeds west westsouth ft. along the north boundary of Survey 48. Following said boundary through a south right angle turn, then to the northwest corner of said survey, then proceeding to the northeast corner of Survey 50, Blk. 16, T&P Lands.
- 40. Thence the line proceeds west westsouth along the south boundary of Survey 49 Blk. 16 T&P Lands to the southwest corner of said survey. Proceeding south southeast along a projection of the west boundary of said survey to the south boundary of Survey 50.
- 41. Thence the line proceeds west to the northwest corner of Alexander Thompson Survey. At said corner the line proceeds south along the west boundary of said survey to the southeast corner of Survey 51 Blk. 16 T&P Lands.
- 42. Thence the line proceeds west westsouth along the north boundary of Surveys 54, 53, and 23 Blk. 16 T&P Lands to the northwest corner of Survey 23.
- 43. Thence the line proceeds south southeast along the west boundary of Survey 23 Blk. 16 T&P Lands to the midpoint of the east boundary of Survey 25. Said point being the southeast corner of the northeast quarter section of Survey 25.
- 44. Thence the line proceeds west westsouth to the intersecting west boundary of Survey 25.
- 45. Thence the line proceeds south with the west boundary of Survey 25 to the southwest corner of said survey.
- 46. Thence the line proceeds west along the north boundary of Survey 29 Blk. 16 T&P Lands to a point. Said point being a corner of the City of Tye's ETJ, the northwest corner of Survey 29 and a right angle curve in TCR #495. Said point also being the ending point of this description.

## Five Mile Extra Territorial Jurisdictional Boundary

- 1. Beginning at a point on the Jones/Taylor County line some 6600 ft. east of FM 707, along the county line. Then proceeding west westsouth along a projection of the north boundary of K.K. Leggett Survey some 8000 ft. to the northwest corner of said survey.
- 2. Thence south southeast along the west boundary of K.K. Leggett Survey to the point of intersection with Mulberry Creek.
- 3. Thence following the meandering of Mulberry Creek in a westerly direction to the point of intersection with the northern boundary of the H. Hand Survey where the line proceeds west to the northernmost northwest corner of said survey.
- 4. Thence south and west with the boundary of said survey to the northeast corner of S.H. Darden Survey.
- 5. Thence turning west westsouth along the north boundary of said survey to the northwest corner. Then proceeding along the west boundary to Mulberry Creek.
- 6. Thence following the meandering of Mulberry Creek in a general southwest direction to a point where Interstate Hwy. 20 crosses said creek.
- 7. Thence the line proceeds south southeast parallel to TCR #287 some 5200 ft. west of the r.o.w. to the intersection of TCR #640. Said point being on the north boundary of W.R. Willis Survey some 5200 ft. from the northeast corner of said survey.
- 8. Thence proceeding west westsouth along the north boundary of said survey the line comes to a point some 8700 ft. from the northeast corner.
- 9. Thence the line proceeds south southeast parallel to and some 8700 ft. west of TCR #287. The line transverses W.R. Willis Survey to the south boundary of said survey some 8700 ft. from the northeast corner of Guadalupe County School Survey 121. Said boundary also being the r.o.w. of FM 1235.
- 10. Thence turning west westsouth along the north boundary of said survey to a point some 10,700 ft. west of the northeast corner of said survey.
- 11. Thence the line proceeds south southeast parallel to and some 10,700 ft. west of F.M. 1235 to a point on TCR #317 also known as the south boundary of said survey at a distance of some 10,520 ft. along the boundary from the southeast corner of Guadalupe County School Survey 121.
- 12. Thence east eastnorth along said boundary to a point where the Santa Fe railroad track crosses said boundary.
- 13. Thence, southeast along the railroad to a point on TCR #297. Turning south southeast the line travels along the r.o.w. of said roadway to the intersection with TCR #296.

14. Thence traveling east eastnorth along said road to the midpoint between TCR #297 and FM 1235.

- 15. Thence the line proceeds south southeast parallel to and some 2800 ft. west of F.M. 1235 for some 3100 ft. to a point on TCR #295.
- 16. Thence the line follows the r.o.w. of said roadway to U.S. Hwy. 277 then turning south southeast follows the r.o.w. of FM 1235 to a point. Said point being the southeast corner of Guadalupe County School Land Survey #120.
- 17. Thence proceeding east following FM 1235 to the intersection of Little Elm Creek.
- 18. Thence following the meandering of said creek the line proceeds south to a point on the northernmost boundary of Survey 11 Blk. 2 SPRR Lands some 500 ft. from the northwest corner of said survey.
- 19. Thence the line travels west westsouth that 500 ft. to the northwest corner, turning and traveling along the west boundary to the southwest corner then proceeding along the south boundary to a point. Said point being some 2300 ft. from the southwest corner of said survey.
- 20. Thence turning south southeast the line bisects Survey 9 to the midpoint of the boundary of said survey. Said point being the southwest corner of the southeast quarter section of said survey.
- 21. Thence in a northeasterly direction along the south boundary of Surveys 9 and 10 Blk. 2, SPRR Co. Lands to the most southern southeasterly corner of Survey 10.
- 22. Thence in a northwesterly direction to the northernmost northwest corner of R.C. Lyon Survey.
- 23. Thence in a northeasterly direction to the northeast corner of said survey and the most southerly corner of the Jones Survey.
- 24. Thence in a northwesterly direction along the west boundary of the Jones Survey to the northwest corner of said survey.
- 25. Thence east along the north boundary of the Jones and J. Mann Surveys a distance of some 2025 ft. to a point in the west boundary of R.A. Hobbs Survey.
- 26. Thence south along the west boundary of R.A. Hobbs Survey to a point of intersection with the projection of the south boundary of L. Strickland Survey 54.
- 27. Thence east with said projection of the south boundary of L. Strickland Survey and the south boundary of said survey some 2680 ft. to a point on the west boundary of N. Reed Survey. Said point being the most southern southeast corner of L. Strickland Survey 54.


28. Thence north along the west boundary line of N. Reed Survey to the northwest corner of said survey.

- 29. Thence east along the northern boundary of N. Reed Survey to the point of intersection with F.M. 89 r.o.w.
- 30. Thence the line proceeds south along said r.o.w. to the point of intersection with the northern boundary of Moses Evans Survey.
- 31. Thence east along said survey boundary line to the northeast corner of said survey.
- 32. Thence south to the southwest corner of J.B. Leggett Survey.
- 33. Thence east along the south boundary of J.B. Leggett Survey to the point of intersection with the northeast corner of J.H. Deaver Survey.
- 34. Thence south to the northwest corner of Survey 50, Blk. 1, SPRR Land.
- 35. Thence east with the north boundary of said survey bisecting Survey 45 Blk. l SPRR Lands, Survey 64 Lunatic Asylum Lands, and Surveys 9 and 8 Blk. l SPRR Lands to the west boundary of Survey 5 Blk. l SPRR Lands. Said point being the southwest corner of the northwest quarter section of Survey 5.
- 36. Thence north with the west boundary of Survey 5 to the northwest corner of said survey.
- 37. Thence east with the north boundary lines of said survey and Survey 60 Lunatic Asylum Lands for a distance of some 10,500 ft. to the northeast corner of Survey 60.
- 38. Thence north with the west boundary of Survey 58 Lunatic Asylum Lands to the midpoint on the boundary of said survey. Said point being the northwest corner of the southwest quarter section of said survey.
- 39. Thence turning east bisecting said survey for a distance of some 5200 ft. to the east boundary line of said survey.
- 40. Thence north along the east boundary of Survey 58 to the northeast corner of said survey, a distance of some 2600 ft.
- 41. Thence east along the north boundary of Surveys 57 and 56 Lunatic Asylum Lands a distance of some 8000 ft. to the midpoint of the north boundary line of Survey 56. Said point being the southwest corner of the southeast quarter section of Survey 49.
- 42. Thence north to the midpoint of Survey 49 Lunatic Asylum lands, a distance of some 2600 ft. to a point. Said point being the northwest corner of the southeast quarter section of said survey.
- 43. Thence east to the intersection of the Taylor-Callahan County line. Then north to the midpoint of the northern boundary of Survey 50, Lunatic Asylum Lands. Said point being the northeast corner of the northwest quarter section of said survey.

44. Thence east along the north boundary of Surveys 50 & 51 Lunatic Asylum Lands to the midpoint on the south boundary of Survey 33. Said point being the southeast corner of the southwest quarter section of said survey.

- 45. Thence north along the east boundary of said quarter section of Survey 33 to a point. Said point being the northeast corner of said section of said survey.
- 46. Thence east to the midpoint of the west boundary of Survey 16, Blk. 8, SPRR Co. Lands.
- 47. Thence north along the west boundary of said survey to the northwest corner of said survey.
- 48. Thence east with the south boundary of Survey 13 Blk. 8 SPRR Lands to the midpoint of said survey boundary. Said point being the southeast corner of the southwest quarter section of said survey.
- 49. Thence north along the north/south half section line of said survey to a point on the north boundary. Said point being the northeast corner of the northwest quarter section of said survey.
- 50. Thence east along the north boundary to the northeast corner of said survey.
- 51. Thence north along the west boundary of Survey 14 Blk. 8 SPRR Lands to the southwest corner of E.O. Weinert Survey.
- 52. Thence east with the south boundary of said survey to the southeast corner of said survey.
- 53. Thence north with the east boundary of said survey to the northwest corner of J.M. Chandler Survey.
- 54. Thence east with the north boundary of said survey and Survey 34 Buffalo Bayou, Brazos and Colorado (BBB and C) RR Co. Lands to the midpoint on the north boundary of said survey. Said point being the southwest corner of the southeast quarter section of said survey.
- 55. Thence north along the west boundary of the southeast quarter section of Survey 35, BBB and C RR Co. Lands to a point. Said point being the northwest corner of said quarter section of said survey.
- 56. Thence east along the north boundary of said quarter section of said survey to the east boundary of said survey.
- 57. Thence north along the east boundary of Survey 35 and continuing along the east boundary of Survey 36 to midpoint of said boundary. Said point being the northeast corner of the southeast quarter section of Survey 36 of said survey.
- 58. Thence east along the south boundary of the northwest quarter section of Survey 43 to a point. Said point being the southeast corner of said quarter section of said survey.

59. Thence north along the west boundary of said quarter section of said survey proceeding north bisecting Surveys 42, 41, 40, and 28 BBB and C RR Lands to the north boundary of Survey 28.



- 61. Thence north with the east boundary of said survey and G.W. Riley Survey to the northeast corner of said survey.
- 62. Thence north northwest along the east boundary of Surveys 68 and 63 Blk. 14 T&P Lands crossing into Shackelford County to the northeast corner of Survey 63.
- 63. Thence west westsouth along the north boundary of said survey to the midpoint. Said point being the northwest corner of the northeast quarter section of said survey.
- 64. Thence north bisecting Survey 62 Blk. 14 T&P Lands to a point on the north boundary of said survey. Said point being the northeast corner of the northwest quarter section of Survey 62.
- 65. Thence west westsouth along the north boundary of Surveys 62 and 61 Blk. 14 T&P Land to the midpoint of the north boundary of Survey 61. Said point being the northwest corner of the northeast quarter section of Survey 61.
- 66. Thence north bisecting Surveys 58 and 55 Blk. 14 T&P Lands to the north boundary of Survey 55. Said point being the northwest corner of the northeast quarter section of Survey 55.
- 67. Thence east eastnorth to the northeast corner of said survey.
- 68. Thence north northwest along the east boundary of Survey 50 to the midpoint on the eastern boundary of Survey 47, Blk. 14 T&P Lands. Said point being the northeast corner of the southeast quarter section of Survey 47.
- 69. Thence east with the east/west half-section line of Survey 48 Blk. 14 T&P Lands to Spring Creek.
- 70. Thence following the meandering of Spring Creek to the intersection with the north boundary of Survey 48.
- 71. Thence east with the north boundary of said survey to the northeast corner. Proceeding north along the east boundary of Surveys 39, 38, 27, 26, and 17 Blk. 14 T&P Lands to the midpoint on the east boundary of Survey 17. Said point being the northeast corner of the southeast quarter section of Survey 17.
- 72. Thence west along the south boundary of the northeast quarter section of Survey 17 to a point. Said point being the southwest corner of said quarter section of said survey.
- 73. Thence north along the west boundary of the said quarter section of said survey to a point on the northern boundary of said survey. Said point being the northwest corner of said quarter section of said survey.

74. Thence west with the north boundary of said survey to the southeast corner of Survey 15 Blk. 14 T&P Lands.

- 75. Thence north along the east boundary of said survey to the northeast corner.
- 76. Thence west along the northern boundary of said survey crossing the Shackelford/Jones County line to the northwest corner.
- 77. Thence north with the east boundary of Survey 9 Blk. 14 T&P Lands to the northeast corner.
- 78. Thence west with the north boundary of said survey to the northwest corner of Survey 9.
- 79. Thence north with the east boundary line of Survey 10 to the northeast corner of said survey.
- 80. Thence west with the north boundary of Survey 10 to the most northern northwest corner of said survey.
- 81. Thence north with the east boundary of the J. Gossner Survey some 900 ft. to a point on said boundary where the projection of the north boundary of D.H. Stover Survey intersects the boundary. Said point being some 3350 ft. north of the southeast corner of J. Gossner Survey.
- 82. Thence west with the projection of the north boundary of Stover Survey and the north boundary of Stover Survey, to the northwest corner of said survey.
- 83. Thence west westsouth with the north boundary of Survey 35 Blk. 15 T&P Lands to the intersection with the east boundary of Survey 32 Blk. 15 T&P Lands.
- 84. Thence south along the east boundary of Survey 32 to the southeast corner of said survey.
- 85. Thence west along the south boundary of said survey and the north boundary of Survey 37 to the northwest corner of said survey.
- 86. Thence south along the west boundary of Survey 37 to the midpoint of said survey boundary. Said point being the northeast corner of the southeast quarter section of Survey 38, Blk. 15, T & P Lands.
- 87. Thence west bisecting said survey to a point on the western boundary. Said point being the northwest corner of the southwest quarter section of said survey.
- 88. Thence south with the west boundary of Survey 38 to the southwest corner.
- 89. Thence west with the north boundary of Survey 47 Blk. 15 T&P Lands to the northwest corner.
- 90. Thence south along the west boundary of said survey to the southwest corner.

91. Thence west along the north boundary of Survey 54 Blk. 15 T&P Lands to the northwest corner of said survey.

- 92. Thence south with the east boundary of R. Smith Survey a distance of some 8600 ft. to a point on the boundary at which a projection of FM 1082 would intersect. Said point being some 8900 ft. north of the southeast corner along the east boundary.
- 93. Thence west along the projection of FM 1082 through R. Smith Survey to the west boundary of said survey being some 3900 ft. north along the boundary from the southwest corner.
- 94. Thence south along the west boundary of R. Smith Survey, across the Clear Fork of Brazos River along the east boundary of M. Millard Survey to unnamed Jones County Rd. Said point being on the east boundary of M. Millard Survey some 11,500 ft. north of the southeast corner.
- 95. Thence west with a projection of the north boundary of Survey 39 Blk. 16 T&P Lands across M. Millard Survey and along the north boundary of Survey 39, 38 and 19 Blk. 16 T&P Lands to the midpoint of the north boundary of Survey 19. Said point being the northwest corner of the northeast quarter section of said survey.
- 96. Thence south along the west boundary of said quarter section of said survey to a point. Said point being the southwest corner of said quarter section of said survey.
- 97. Thence west along the south boundary of the northwest quarter section of said survey to the west boundary of said survey.
- 98. Thence south with the west boundary of said survey to the southwest corner of said survey.
- 99. Thence west with the north boundary of Survey 17 Blk. 16 T&P Lands to the northwest corner.
- 100. Thence south along the west boundary of Survey 17 to Mulberry Creek.
- 101. Thence southwest with the meandering of Mulberry Creek to the Jones/Taylor County line.
- 102. Thence some 1500 ft. west along the county line to the point of beginning.
