

RESOLUTION NO. 46-1989

RESOLUTION CANVASSING ELECTION RETURNS

THE STATE OF TEXAS :  
COUNTIES OF TAYLOR AND JONES :  
CITY OF ABILENE :

WHEREAS, the City Council of said City ordered an election to be held in said City on August 12, 1989, on the PROPOSITION hereinafter stated; and

WHEREAS, said City Council has investigated all matters pertaining to said election, including the ordering, giving notice, officers, holding and making returns of said election; and

WHEREAS, the election officers who held said election have duly made the returns of the result thereof, and said returns have been duly delivered to said City Council.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE:

1. That the City Council officially finds and determines that said election was duly ordered, that proper notice of said election was duly given, that proper election officers were duly appointed prior to said election, that said election was duly held, that due returns of the result of said election have been made and delivered, and that the City Council has duly canvassed said returns, all in accordance with law and the Resolution calling said election.

2. That the City Council officially finds and determines that the following votes were cast at said election, on the submitted PROPOSITION by the resident, qualified electors of said City, who voted at the election:

PROPOSITION NO. 1

The adoption of an additional one-half of one percent sales and use tax within the City to be used to reduce the property tax rate.




