

RESOLUTION NO. 10-1990

A JOINT RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AND THE BOARD OF TRUSTEES, ABILENE INDEPENDENT SCHOOL DISTRICT; APPOINTING VARIOUS ELECTION OFFICIALS FOR THE JOINT CITY/SCHOOL ELECTION FOR THE MAY 5 AND MAY 19, 1990 ELECTIONS.

BE IT JOINTLY RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS AND THE BOARD OF TRUSTEES, ABILENE INDEPENDENT SCHOOL DISTRICT:

PART 1: The following persons are designated as Presiding Judges and Alternate Presiding Judges for their respective voting precincts.

PART 2: The maximum number of clerks for each voting precinct shall be eight (8), and each judge shall attempt to appoint one (1) clerk fluent both in English and Spanish.

PART 3: The rate of compensation shall be Five and 00/100ths (\$5.00) Dollars per hour; provided, however, that each presiding judge delivering returns of the election shall be paid an additional Twenty-Five and 00/100ths (\$25.00) Dollars, for that service.

PART 4: Absentee ballots shall be counted by the Absentee Ballot Board, as provided for by law.


PART 5: That this resolution shall take effect immediately from and after its passage, as indicated below.

PART 6: That the Term of this appointment shall be for the May 5 election and the May 19 runoff election, if necessary.
