## RESOLUTION NO. 33-1991

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, APPOINTING VARIOUS ELECTION OFFICIALS AND FIXING THEIR RATE OF COMPENSATION; AND PROVIDING FOR A PROCLAMATION NOTICE AND PUBLICATION OF NOTICE OF SAID ELECTIONS.

WHEREAS, the City Council has ordered a Charter election for November 5, 1991; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: The following persons are designated as Presiding Judges and Alternate Presiding Judges for their respective voting precincts.

PART 2: The maximum number of clerks for each voting precinct shall be four, and each judge shall attempt to appoint one clerk fluent both in English and Spanish.

PART 3: The rate of compensation shall be Five and 00/100ths (\$5.00) Dollars per hour; provided, however, that each presiding judge delivering returns of the election shall be paid an additional Twenty-Five and 00/100ths (\$25.00) Dollars, for that service.

PART 4: Absentee ballots shall be counted by the Absentee Ballot Board, as provided for by law.

PART 5: That the Mayor shall make proclamation of said City election and give notice thereof, and a copy of this order shall be

sufficient notice of said election. Notice of the time and places of holding said election shall be given by publication of such notice in a newspaper of general circulation published in the City of Abilene at least thirty (30) days prior to the day of such election. The Mayor is further authorized to give notice of a runoff election if such election is necessary.

PART 6: That this resolution shall take effect immediately from and after its passage, as indicated below.
