WHEREAS, the City deems it advisable to give notice of intention to issue Certificates of Obligation in the amount of \$800,000 for paying all or a portion of the City's contractual obligations for the purpose of providing \$470,000 for constructing, improving and repairing the City's streets, drainage, railroad crossings and other crossings and intersection improvements, \$220,000 for Park System repairs and improvements, and \$110,000 for mobile radio system replacement, and for paying legal, fiscal and engineering fees in connection with this project; and

WHEREAS, it is hereby officially found and determined that the meeting at which this Resolution was passed, was open to the public and public notice of the time, place, and purpose of said meeting was given, all as required by Art. 6252-17, V.A.T.C.S.




