

RESOLUTION NO. 37-1994

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, APPROVING A FEE SCHEDULE FOR MAXWELL MUNICIPAL GOLF COURSE, AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City Council, in August, 1986, directed the City Manager and the staff to conduct cost studies from time-to-time of the various fees and charges of the City of Abilene, Texas, and submit recommendations to the City Council for their review and adjustment to and creation of said fees and charges as needed; and

WHEREAS, American Golf Corporation has submitted a request to the City Manager to adjust the fee schedule at Maxwell Municipal Golf Course, and

WHEREAS, the City of Abilene's Parks Board has reviewed the proposed change in fees on September 13, 1994; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

Part 1: That the fee schedule herein called Exhibit 1 and attached hereto, be in all things, approved.

Part 2: That this resolution shall take effect October 1, 1994 after its passage and shall supersede the golf course fee schedule in Resolution #41-1990.


