

RESOLUTION NO. 26-1995

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, DIRECTING STAFF TO PREPARE A SERVICE PLAN FOR PROPOSED ANNEXATION OF CERTAIN PROPERTY.

WHEREAS, the City Staff has made recommendations concerning proposed annexation of property; and,

WHEREAS, it is the opinion of the City Council that Public Hearings on the proposed annexation of certain property should be held; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the City Council hereby directs the Planning Division to prepare a Service Plan for the proposed annexed property, Exhibit "A", which is made a part of this resolution for all purposes.

PART 2: That this resolution shall take effect immediately from and after its passage.

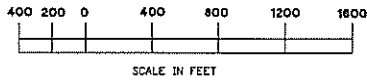

JULY 27

(1) City Council:

Resolution by City Council directing the preparation of Service Plan. (Sec. 43.056)

AUGUST 7

(2) Planning Department:

(a) Complete Service Plan prior to publication of Notice of Public Hearings.

(b) Develop with Engineering Department a legal description.

AUGUST 7

(3) City Secretary:

Deliver Notice to newspaper for publication.

AUGUST 11

(4) City Secretary:

(a) Publish Notice in newspaper of Public Hearings to be held not sooner than 10 nor later than 20 days after Notice.

(b) Notify Railroad by Certified Mail. (Sec. 43.052)

AUGUST 23

(5) City Council:

Hold 1st Public Hearing on date set in newspaper notice (in Council Chambers).

AUGUST 24

(6) City Council:

Hold 2nd Public Hearing on date set in newspaper notice (in Council Chambers or in annexed area). (Sec. 43.052)

SEPTEMBER 28

(7) City Council:

1st reading of Annexation Ordinance (not less than 20 nor more than 40 days after Public Hearings). (Sec. 43.052)

SEPTEMBER 28

(8) City Secretary:

Deliver Ordinance to newspaper for publication.

- OCTOBER 4 (9) City Secretary:  
Publish Annexation Ordinance in newspaper, one (1) time in form to be passed, including legal description. (Sec. 4 of City Charter)
- NOVEMBER 6 (10) City Secretary:  
Deliver Notice to newspaper for publication
- NOVEMBER 10 (11) City Secretary:  
Publish Notice in newspaper, one (1) time of Public Hearing for 2nd reading of Annexation Ordinance. (Sec. 18 of City Charter)
- NOVEMBER 16 (12) City Council:  
Hold Public Hearing on date set in newspaper notice, 2nd reading of Annexation Ordinance, (30 days after 1st reading of Annexation Ordinance and publication of Annexation Ordinance in newspaper). (Sec. 4 of City Charter)
- NOVEMBER 17 (13) Planning Department:  
Prepare Voting Rights data as soon as possible.
- DECEMBER 11 (14) City Attorney:  
Submit Voting Rights Submission to U.S. Justice Department.
