PART 1: That the City Council of the City of Abilene finds and declares the results of such elections as per the attached Exhibit "A".

PART 2: It appearing that Kris Southward received the majority of votes cast in said General runoff election for the office of Council Place 2; and Victor G. Carrillo received the majority of votes cast in said Special runoff election for the office of Council Place 3.

PART 3: That this resolution shall take effect immediately from and after its passage.
