

RESOLUTION NO. 9-2000

A JOINT RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AND THE BOARD OF TRUSTEES, ABILENE INDEPENDENT SCHOOL DISTRICT, APPOINTING VARIOUS ELECTION OFFICIALS FOR THE MAY 6, 2000 JOINT CITY/SCHOOL ELECTION, SPECIAL CITY ELECTION, AND RUN OFF ELECTION, IF NECESSARY, AND FIXING THEIR RATE OF COMPENSATION.

WHEREAS, the Abilene City Council has previously ordered an election for Council Places 1 and 2 and the unexpired term of Council Place 3 for May 6, 2000, and

WHEREAS, on May 6, 2000 Abilene Independent School District will conduct an Election for Trustee Places 1, 2, 3, and 7, and

WHEREAS, Abilene Independent School District and the City have agreed that holding a joint election will benefit the voters; now, therefore,

BE IT JOINTLY RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AND THE BOARD OF TRUSTEES OF THE ABILENE INDEPENDENT SCHOOL DISTRICT:

PART 1: The City of Abilene and Abilene Independent School District agree to hold a joint election on May 6, 2000.

PART 2: The following persons are designated as Presiding Judges and Alternate Presiding Judges for their respective voting precincts:

**PART 3:** The maximum number of clerks for each voting precinct shall be six, and each judge shall attempt to appoint one clerk fluent both in English and Spanish.

**PART 4:** The rate of compensation shall be Five and 15/100ths (\$5.15) Dollars per hour; provided, however, that each presiding judge delivering returns of the election shall be paid an additional Twenty-Five and 00/100ths (\$25.00) Dollars, for that service.

**PART 5:** Early voting ballots shall be counted by the Early Voting Ballot Board, as provided for by law.

**PART 6:** That this joint resolution shall take effect immediately from and after its passage, as indicated below.

**PART 7:** That the Terms of this appointment shall be for the May 6th election and June 3, 2000 City run off election, if necessary.


