

RESOLUTION NO. 16-2001

A RESOLUTION DESIGNATING NAMES OF INTERNAL ACCESS WAYS FOR 911 AND OTHER ADDRESSING PURPOSES IN THE DYESS AFB HOUSING PRIVATIZATION PROJECT AND THE HENDRICK HEALTH SYSTEM COMPLEX.

WHEREAS, delivery of emergency response services can be improved by assigning specific addresses for buildings based upon adjacent streets or access ways;

WHEREAS, the Dyess AFB Housing Privatization project developer and the Hendrick Health System complex have worked with the City to develop a system of names for the internal access ways on their respective developments;

WHEREAS, these names for the internal access ways and their application are consistent with the City's street name policies;

WHEREAS, the names for internal access ways are shown for the Dyess AFB Housing Privatization project in Exhibit A and for the Hendrick Health System complex in Exhibit B; now therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:


PART 1: The names of access ways in Exhibit A and Exhibit B are hereby designated as official names for 911 and other addressing purposes.

Aviator Dr	From Kala Dr, 200 feet northeast of Rebecca Ln, north to dead end
Catalina Ct	From Catalina Dr, 100 feet east of American Dr, north and south to dead ends
Catalina Dr	From American Dr, 1400 feet north of Kala Dr, east to Catalina Ct
Clipper Ct	From Clipper Dr, 100 feet east of American Dr, north and south to dead ends
Clipper Dr	From American Dr, 1200 feet north of Kala Dr, east to Clipper Ct
Marauder Ct	From Marauder Dr, 100 feet east of American Dr, north and south to dead ends
Marauder Dr	From American Dr, 1000 feet north of Kala Dr, east to Marauder Ct
Patriot Dr	From Rebecca Ln, 1700 feet southeast of US 277, northeast and then northwest to dead end
Timbercat Ct	From Timbercat Dr, 100 feet east of American Dr, north and south to dead ends
Timbercat Dr	From American Dr, 800 feet north of Kala Dr, east to Timbercat Ct
Victory Dr	From Patriot Dr, 1400 feet north of Rebecca Ln, east to American Dr
