

RESOLUTION NO. 14-2002

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD IN THE CITY OF ABILENE ON MAY 4, 2002.

WHEREAS, on the 14th day of February, A.D. 2002, the City Council of the City of Abilene, by proper resolution and proclamation, called an election to be held in said City on the 4th day of May 2002, in accordance with the provisions of the Charter of said city, for the purpose of electing persons to serve as Mayor and in Council Places 3 & 4 and,

WHEREAS, the City Council has duly canvassed the returns of such elections and has ascertained the results thereof; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the City Council of the City of Abilene finds and declares the results of such elections as per the attached Exhibit "A".

PART 2: It appearing that Grady Barr received the majority of votes cast in said General election for the office of Mayor; that Anthony Williams received the majority of votes cast in said General election for the office of Council Place 3; and that John Hill received the majority of votes cast in said General election for the office of Council Place 4;

PART 3: Per the canvassed returns, the City Council of the City of Abilene declares Grady Barr elected as Mayor, Anthony Williams elected to City Council Place 3, and John Hill elected to City Council Place 4; and


PART 4: That this resolution shall take effect immediately from and after its passage.
