

RESOLUTION NO. 29-2002

A RESOLUTION OF THE CITY OF ABILENE, TEXAS, REVISING RESOLUTION NO. 32-2001, THE SCHEDULE OF RATES AND CHARGES FOR THE SOLID WASTE SERVICES DIVISION, ADOPTED July 26,2001.

WHEREAS, in December, 1984, the City Council revised Chapter 27, Refuse, of the Abilene Municipal Code to provide for the establishment of amounts and procedures to be followed in regard to fees, deposits, and bills by way of City Council Resolution rather than Ordinance; and,

WHEREAS, Section 27-65 and Section 27-95 of the Abilene Municipal Code provide for the establishment of a Schedule of Rates and Charges for the Solid Waste Services Division; and,

WHEREAS, the Schedule of Rates and Charges for the Solid Waste Services Division has from time to time been revised by the Council; and,

WHEREAS, at this time there is need to revise said Schedule of Rates and Charges for the Solid Waste Services Division; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:


PART 1: That the Schedule of Rates and Charges for the Division currently in effect is hereby amended by the Schedule of Rates and Charges for the Solid Waste Services Division attached hereto as Addendum to Exhibit "A".

PART 2: That this Schedule of Rates and Charges for the Solid Waste Services Division shall be kept on file in the City Secretary's office and in the Solid Waste Services Division office.


PART 3: That the effective date of this section shall be immediate.

Schedule of Rates and Charges for the
Solid Waste Services Division

IV. Recycling Environmental Services

Each residential and commercial refuse collection account will be assessed a fifty (.50) cents per month recycling environmental fee.

A. Cardboard Recycling Services

1. Scheduled Service Collection

<u>Container Size</u>	<u>Once Per Week</u>	<u>Twice Per Week</u>	<u>Each additional Container At the Same Location</u>
<u>8 cubic yard</u>	<u>\$55.00</u>	<u>\$80.00</u>	<u>\$25.00</u>

2. Non- Scheduled Service

<u>Container Size</u>	<u>Monthly Charge</u>
<u>40 yard</u>	<u>\$80.00</u>

B. Work Place Recycling Services

Paper (blue bag), cardboard (orange bag), plastic drink containers (green container), aluminum cans (white cardboard containers).

1. Pick up at collection point - \$2.00 per bag/container, per month
2. Pick up at a central point per building - \$1.00 per bag/container, per month
3. Pick up at a single point in complex - \$.50 bag/container, per month

III. Commercial Collection Service (Non-Residential)

A. Frontloader Services

2. Non-Scheduled Service- The following charge shall apply for short-term use (less than seven days) of a commercial container: \$35.00 per empty.
