CITY OF ABILENE NOTICE OF INTENTION TO ISSUE COMBINATION TAX AND REVENUE CERTIFICATES OF OBLIGATION, SERIES 2002

The City of Abilene does hereby give notice of intention to issue Combination Tax and Revenue Certificates of Obligation, Series 2002, in the maximum principal amount not to exceed \$3,700,000 for paying in whole or in part a portion of the City's contractual obligations for the purpose of constructing municipal facilities improvements which include park and recreation improvements, constructing improvements and repairs to City streets, together with traffic and street signalization improvements, and improving and renovating the City Hall, City owned Cypress Plaza Building, Adaptive Recreation Center and Civic Center, and for paying legal, fiscal, and engineering fees in connection with such projects. The City proposes to provide for the payment of such Certificates of Obligation from the levy and collection of ad valorem taxes in the City as provided by law, and from the limited surplus revenues of the City's Waterworks and Sewer System, remaining after payment of all operation and maintenance expenses thereof, and all debt service, reserve, and other requirements in connection with all of the City's revenue bonds or other obligations (now or hereafter outstanding), which are payable from all or any part of the Net Revenues of the City's Waterworks and Sewer System, not to exceed \$2,500.
