

RESOLUTION NO. 17-2004

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL AND SPECIAL RUNOFF ELECTIONS HELD IN THE CITY OF ABILENE ON JUNE 19, 2004.

WHEREAS, on the 12th day of February, A.D. 2004, the City Council of the City of Abilene, by proper resolution and proclamation, provided for runoff elections, if necessary, to be held in said City on the 19th day of June, 2004, in accordance with the provisions of the Charter of said City, and as provided by applicable laws of the State of Texas and,

WHEREAS, no candidate received a majority of the votes cast for the office of Council Places 5 and 1 in the General and Special Elections held the 15th day of May 2004, and,

WHEREAS, the City Council has duly canvassed the returns of the General and Special Runoff Elections held June 19, 2004 and has ascertained the results thereof; now therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the City Council of the City of Abilene finds and declares the results of such elections as per the attached Exhibit "A".


