RESOLUTION NO. 6-2005

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS; DESIGNATING ELECTION PRECINCTS AND POLLING PLACES; APPOINTING VARIOUS ELECTION OFFICIALS AND FIXING THEIR RATE OF COMPENSATION; AND PROVIDING FOR A PROCLAMATION NOTICE AND PUBLICATION OF NOTICE FOR THE MAY 7, 2005 CITY GENERAL ELECTION.

WHEREAS, the Abilene City Council has previously ordered an election for May 7, 2005 to provide for the election of persons to serve as Mayor and Places 3 and 4 on the City Council of Abilene;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

SECTION 1: That the Mayor shall make proclamation of said City election and give notice thereof, and a copy of this order shall be sufficient notice of said election. Notice of the time and places of holding said election shall be given by publication of such notice in a newspaper of general circulation published in the City of Abilene at least thirty (30) days prior to the day of such election. The Mayor is further authorized to give notice of a run-off election if such election is necessary. Said elections shall be held pursuant to the laws of the State of Texas, the Charter of the City of Abilene, Texas, and a contract between the City of Abilene and the Taylor County Elections Office for election services.

SECTION 2: That should any elections be ordered to be held within the jurisdiction of the City of Abilene, Texas, this resolution shall govern, unless or until this resolution is changed or amended by the City Council of Abilene, Texas. Said elections shall be held pursuant to the laws of the State of Texas, the Charter of the City of Abilene, Texas, and a contract between the City and the Taylor County Elections Office for election services. All elections shall be conducted as an atlarge election.

SECTION 3: Said election shall be held in the designated election precincts, and voting shall be conducted at the designated polling places shown below:

SECTION 5: The maximum number of clerks for each voting precinct shall be three, and each judge shall attempt to appoint one clerk fluent both in English and Spanish.

SECTION 6: The rate of compensation shall be Five and 15/100ths (\$5.15) Dollars per hour; provided, however, that each presiding judge delivering returns of the election shall be paid an additional Twenty-Five and 00/100ths (\$25.00) Dollars, for that service.

SECTION 7: Early voting ballots shall be counted by the Early Voting Ballot Board, as provided for by law.

SECTION 8: That this resolution shall take effect immediately from and after its passage, as indicated below.
