CITY OF ABILENE NOTICE OF INTENTION TO ISSUE COMBINATION TAX AND REVENUE CERTIFICATES OF OBLIGATION, SERIES 2006

The City of Abilene does hereby give notice of intention to issue Combination Tax and Revenue Certificates of Obligation, Series 2006, in the maximum principal amount not to exceed \$4,645,000 for paying in whole or in part a portion of the City's contractual obligations for the purpose of constructing improvements and repairs to City streets, hiking and bike trails, together with drainage, traffic and street signalization improvements, sidewalk improvements, constructing, improving and equipping the City's park and recreation system, constructing and equipping a fire training facility and acquiring fire equipment, improving City Hall, animal service facility, fleet maintenance facility, solid waste building, bus terminal, and civic center, improving streets, right of way, sidewalks and utilities in redevelopment areas, and for paying legal, fiscal, and engineering fees in connection with such projects. The City proposes to provide for the payment of such Certificates of Obligation from the levy and collection of ad valorem taxes in the City as provided by law, and from the limited surplus revenues of the City's Waterworks and Sewer System, remaining after payment of all operation and maintenance expenses thereof, and all debt service, reserve, and other requirements in connection with all of the City's revenue bonds or other obligations (now or hereafter outstanding), which are payable from all or any part of the Net Revenues of the City's Waterworks and Sewer System, not to exceed \$2,500. The City Council intends to consider for passage at a Special Meeting to be held at 11:30 A.M., C.S.T., on July 20, 2006, an Ordinance authorizing the issuance of City of Abilene, Texas Combination Tax and Revenue Certificates of Obligation, Series 2006, at the City Hall, Abilene, Texas.
