That the City Secretary shall cause said notice to be published in substantially the form attached hereto, in a newspaper of general circulation in said City, and published in said City, on the same day in each of two consecutive weeks, the date of the first publication thereof to be at least 14 days prior to the time set for the issuance of such certificates of obligation as shown in said notice.
 - 3. That this Resolution shall become effective immediately upon adoption.

The City of Abilene does hereby give notice of intention to issue Combination Tax and Airport Revenue Certificates of Obligation, Taxable Series 2006, in the maximum principal amount not to exceed \$1,205,000 for paying all or a portion of the City's contractual obligations for the purpose of improving, expanding, renovating and equipping the Abilene Regional Airport Terminal and related parking, together with runway, taxiway and ramp improvements and for paying legal, fiscal, and engineering fees in connection with such projects. The City proposes to provide for the payment of such Certificates of Obligation from the levy and collection of ad valorem taxes in the City as provided by law, and from the Net Revenues of the City's Airport, remaining after payment of all operation and maintenance expenses thereof, and all debt service, reserve, and other requirements in connection with all of the City's revenue bonds or other obligations (now or hereafter outstanding), which are payable from all or any part of the Net Revenues of the City's Airport.
