

RESOLUTION NO. 33-2006

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, APPOINTING VARIOUS ELECTION OFFICIALS AND FIXING THEIR RATE OF COMPENSATION FOR THE NOVEMBER 7, 2006 TAYLOR COUNTY GENERAL/CITY OF ABILENE SPECIAL ELECTION.

WHEREAS, the Abilene City Council has previously ordered a special election to allow the voters to recommend whether or not the Council should adopt an ordinance to ban smoking in all public places and places of employment in the City of Abilene, Texas; for voter consideration of the Constitutional amendment authorizing a tax freeze limiting the amount of ad valorem taxes imposed on the residential homestead of a person who is disabled or 65 years of age or older in the City of Abilene, Texas; and to allow voters to consider amending Sections of the Charter of the City of Abilene to comply with state law; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the City of Abilene agrees to hold an election on November 7, 2006 in conjunction with the Taylor County General and State Gubernatorial Election.

PART 2: The following persons are designated as Presiding Judges and Alternate Judges for their respective voting precincts:

PART 3: The maximum number of clerks for each voting precinct shall be six, and each judge shall attempt to appoint one clerk fluent both in English and Spanish.

PART 4: The rate of compensation shall be Five and 15/100ths (\$5.15) Dollars per hour; provided, however, that each presiding judge delivering returns of the election shall be paid an additional Twenty-Five and 00/100ths (\$25.00) Dollars, for that service.

PART 5: Early voting ballots shall be counted by the Early Voting Ballot Board, as provided for by law.

PART 6: That this resolution shall take effect immediately from and after its passage, as indicated below.

PART 7: That the terms of these appointments shall be for the November 7, 2006 election.


