# Resolution # 3-2008

A RESOLUTION OF THE CITY OF ABILENE, TEXAS APPROVING A JOINT ELECTION AGREEMENT WITH ABILENE INDEPENDENT SCHOOL DISTRICT, WYLIE INDEPENDENT SCHOOL DISTRICT, LYTLE LAKE WATER AND IMPROVEMENT DISTRICT AND THE CITY OF IMPACT.

**WHEREAS**, Sec.11.0581 of the Texas Education Code requires school districts to hold joint elections for their board of trustees; and

WHEREAS, Sec. 11.0581(a)(1) of the Texas Education Code allows for the joint election to be held with the election for the members of the governing body of a municipality located in the school district; and

WHEREAS, Section 11.0581(c) of the Texas Education Code requires that the voters of a joint election be served by common polling places; and

WHEREAS, Section 271.003(b) of the Texas Election Code allows the common polling locations to be outside the boundary of the election precinct or political subdivision if the location can adequately and conveniently serve the affected voters and will facilitate the orderly conduct of the election; and

WHEREAS, the City of Abilene ("City"), the Abilene Independent School District ("AISD"), the Wylie Independent School District ("WISD"), the City of Impact ("Impact") and Lytle Lake Water Control and Improvement District ("LLWCID") anticipate holding an election on May 10, 2008; and

**WHEREAS**, the City has expressed its willingness to hold its election jointly with AISD, WISD, Impact, and LLWCID; and

WHEREAS, common polling locations have been found that adequately and conveniently serve the affected voters and that will facilitate the orderly conduct of the election; and

WHEREAS, Sec. § 271.002(a) of the Texas Election Code provides that the governing bodies of the political subdivisions may enter into an agreement to hold the elections jointly in the election precincts that can be served by common polling places;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the City of Abilene hold its May 10, 2008 election jointly with AISD, WISD, Impact, and LLWCID under the terms of the Joint Election Agreement attached as Exhibit A and made part of this Resolution for all purposes.

PART 2: That the Mayor of the City of Abilene is authorized to execute the Agreement.

PART 3: That the common polling locations attached as Exhibit B and made part of this Resolution for all purposes will be used for the joint election.
