A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS CANVASSING RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION AND SPECIAL ELECTION TO LEGALIZE THE SALE OF ALL ALCOHOLIC BEVERAGES INCLUDING MIXED BEVERAGES, HELD ON MAY 8, 2010.

*(UNA RESOLUCION DEL CONSEJO DE LA CIUDAD DE ABILENE TEXAS, REVISANDO LA RESPUESTA Y DECLARANDO LOS RESULTADOS DE LA ELECCION GENERAL Y ELECCION ESPECIAL PARA LEGALIZAR LA VENTA DE BEBIDAS ALCOHOLICAS INCLUYENDO BEBIDAS MIXTAS, QUE SE LLEVARAN ACABO EL 8 DE MAYO DEL 2010.)*

WHEREAS, on the 25<sup>th</sup> day of February, A.D. 2010, the City Council of the City of Abilene, by proper resolution, ordered a General election to be held in said City on the 8<sup>th</sup> day of May, 2010, in accordance with the provisions of the Charter of said city, for the purpose of electing persons to serve in Council Places 5 & 6; and

WHEREAS, on the 25<sup>th</sup> day of February, A.D. 2010, the City Council of the City of Abilene, by proper resolution ordered a Special election to be held in conjunction with the City's General Election on the 8th day of May, 2010, for the purpose of voting For or Against "The Legal sale of all alcoholic beverages including mixed beverages"; and

PARTE 4: Al parecer la Eleccion Especial Local para Legalizar "La venta de bebidas alcoholicas incluyendo bebidas mixtas", Paso 1740 a Favor, 1370 En Contra; y


